Purpose of Report and Disclaimer

This report supplements the 1st Quarter Crime Report by providing quarterly crime data tables by Patrol Division. The divisional enforcement highlights and information about crime suppression efforts can be found in the 1st Quarter Crime Report and were not replicated within this supplement.

This report is a snapshot of the Fort Worth Police Department's National Incident-Based Reporting System (NIBRS) data that was queried from the Records Management System (RMS) on April 18, 2011. The Department's RMS is updated regularly based on ongoing investigations, but a snapshot of this data is taken at the point that the Texas Department of Public Safety has reviewed and certified the data so that the Fort Worth Police Department has the ability to provide more detailed data, including information at the Council District level and at the Patrol Division level. It should be noted that since this is a snapshot, data queried before or after this date is apt to change and may vary from other reports.

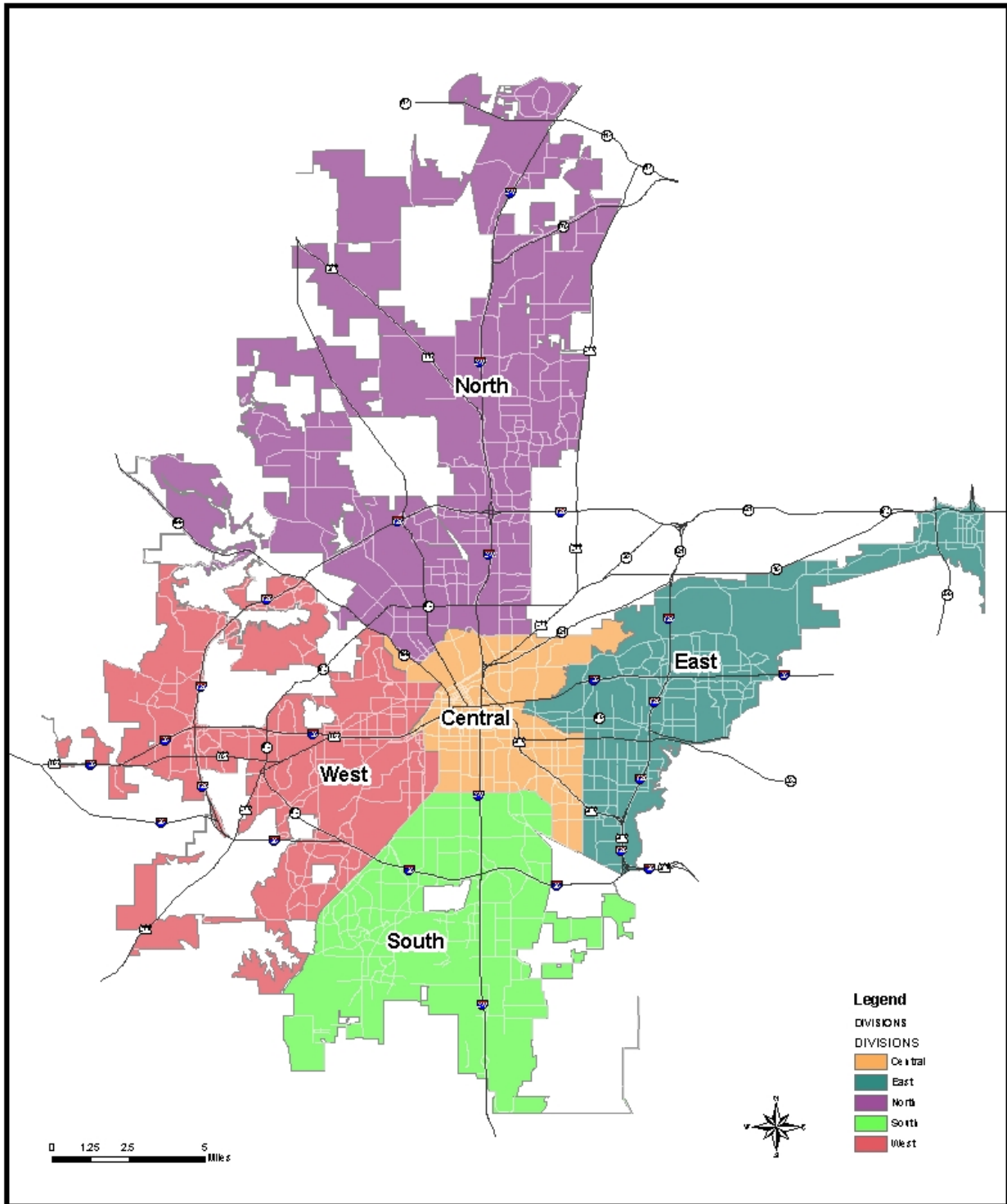
Figure 1—Summary of Offenses By Patrol Division
