FAMILY VIOLENCE OFFENSES

The Texas Family Code states that “family” includes individuals that are related by consanguinity (blood) or affinity (marriage), individuals who are former spouses, individuals who are the biological parents of the same child without regard to marriage, and a foster child or parent, regardless of whether these individuals reside together.

Family Violence means an act by a member of a family or household against another member of that family or household that is intended to result in physical harm, bodily injury, assault, or sexual assault or that is a threat that reasonably places the member in fear of imminent physical harm, bodily injury, assault or sexual assault but does not include defensive measures to protect oneself; or abuse by a member of a family or household toward a child of the family or household. This includes dating violence.
